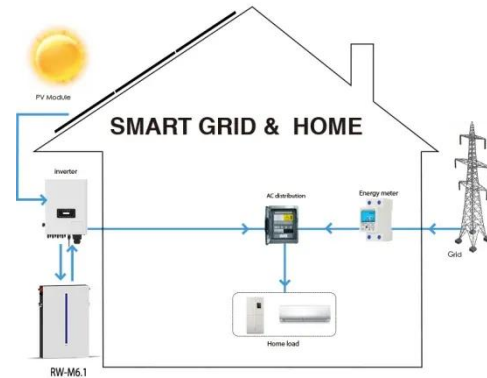


Chart of Accounts Setup for Solar Business
