Grenada's customs tariffs can be found on its customs website ([www.grenadacustoms.gov.gd](http://www.grenadacustoms.gov.gd)). For misdeclared goods, customs will impose a fine of 5 times the value of the goods or 100,000 ECD. When engaging in the import and export of goods in Grenada, understanding the customs procedures is crucial for effective trade compliance. Traders must submit essential documents including invoices, packing lists, bills of lading, and bills of exchange.
