Overview

Enclosed space entry remains one of the most dangerous operations at sea. Every year, seafarers, dock workers, and surveyors lose their lives in spaces that seem routine—chain lockers, tanks, holds—often because of a single missed step or a moment's complacency. 5 of the 2010 Standards expand this exception by removing the condition that the exempt spaces be "non-occupiable," and by separating the other conditions into two independent exceptions: one for spaces with limited means of access, and the other for machinery spaces. The Americans with Disabilities Act (the ADA) was passed to improve the accessibility of public utilities, including mail lockers and storage, for disabled citizens. There might be another very very small locker, but it isn't much. Did your berthings not have stand up lockers?

We also had people who stowed shit in work spaces and there are spaces on the ship to stow suitcases for. Do you want to make sure your lockers are compliant with the 2010 ADA Design Standards for Accessible Design?

Very close to what we had on the destroyer I was on. Every locker had a stand up (half size) and a coffin rack with plenty of storage space for your civilian clothes and uniforms.

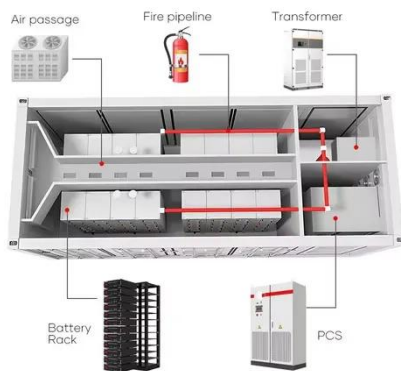
