They do offer net metering to sell back excess solar. However, there are no state-mandated policies, so the price is negotiated. Large-scale grid-side energy storage or bile energy storage is used for power supply. During a power outage, stored electricity can be used to continue operations without interruptions. 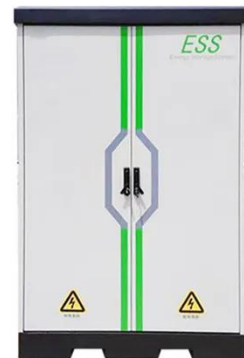
