

# Electric vehicle incentives mauritius



## Overview

---

In July 2025, Mauritius implemented new rules for electric vehicle (EV) imports, increasing costs and removing prior incentives. Key changes include:

**Excise Duties Introduced:** EVs up to 180 kW now face a 15% duty, while those above 180 kW are taxed at 25%. Previously, EVs were duty-free.

**Rebates.** The Mauritian government is taking significant steps to curb vehicle sales. Starting J, it will increase excise duties on traditional fuel vehicles and reintroduce taxes on hybrid and electric models. In addition, duty on hybrid motor cars has been brought down to 30 percentage points for all cylinder capacity.
