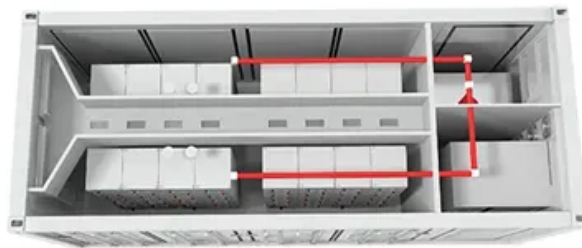

The national grid has experienced a significant decrease in electricity demand since the conflict, with Khartoum and Gazira, which previously accounted for 75% of the demand, being disconnected due to transmission network damages. Consequently, Sudan currently has a generation surplus for the first. Electricity can be generated in two main ways: by harnessing the heat from burning fuels or nuclear reactions in the form of steam (thermal power) or by capturing the energy of natural forces such as the sun, wind or moving water. of total generation Electricity production tends to closely match. try of Energy and Mining. 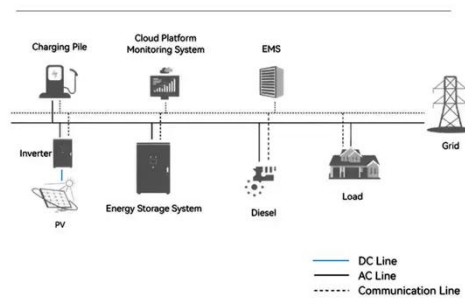
