This guide explains your rights and potential ways to resolve your contract. Contracts often last 20 years or more. You don't buy the system or own anything installed on your property during the term of the contract, you're entitled to use all the power the system produces. The use of solar panels has surged across the United States as homeowners. A Solar Power Purchase Agreement (SPPA) is a financial arrangement in which a third-party developer owns, operates, and maintains the photovoltaic (PV) system, and a host customer agrees to site the system on its property and purchases the system's electric output from the solar services provider.

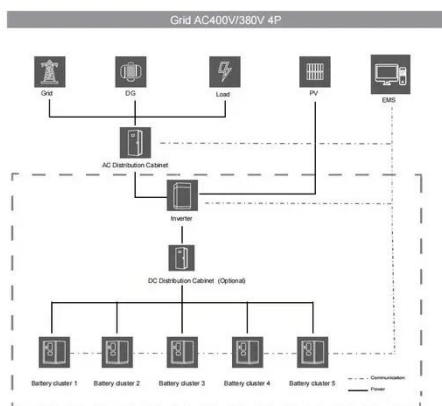
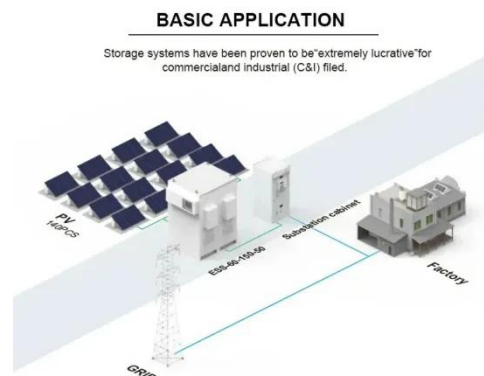

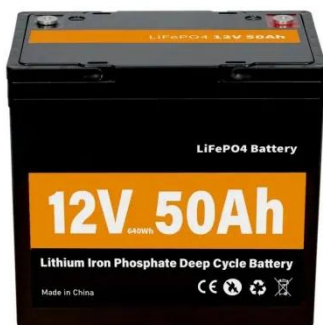
