Overview

Pursuant to Section 7 of the Liquid Fuels and Gas (Production and Supply) Act of 2004 and Regulation 27 of the 2009 Regulations, all fuel private storage owners, exceeding 400 litres, must be registered by MERA. [Note: This version of the Act was revised and consolidated in the Fifth Revised Edition of the Laws of Malawi (L. 1/2018), by the Solicitor General and Secretary for Justice under the authority of the Revision of the Laws Act.] An Act to establish an Energy Regulatory Authority to regulate the.
