DO NOT USE THESE SHIPPING INSTRUCTIONS FOR. This compliance resource was prepared to assist a shipper to safely package lithium cells and batteries for transport by all modes of transportation according to the latest regulatory requirements. While most lithium batteries are safe, some. Some batteries are regulated when shipped or offered for transportation. If the battery is restricted, then all applicable hazardous materials regulations must be met. For new shippers, the five fundamentals in this guide are where to start to identify relevant regulatory requirements and determine how strictly a shipment w vs. lithium-ion cells types—lithium-metal and lithium-ion. What seems like an everyday item on store shelves becomes a compliance headache the moment it enters the freight and fulfillment system. This publication directs readers to scenario-based shipping guides that outline the requirements.
