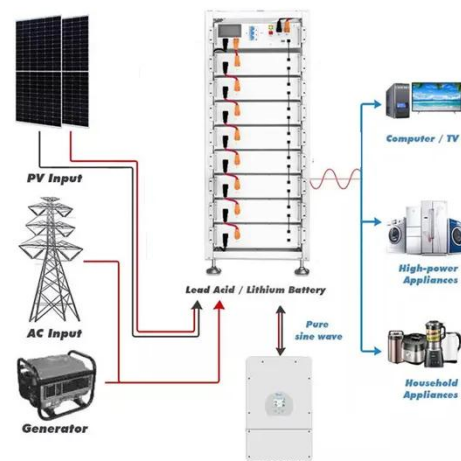

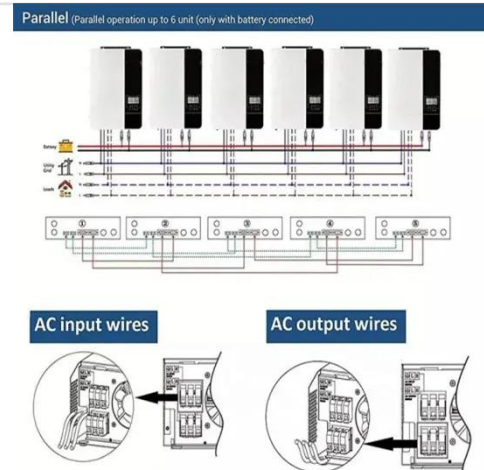
Obtaining a permit ensures your sunroom is built safely and meets all local building codes. Failure to obtain a permit can result in fees, fines, or a teardown of the construction.

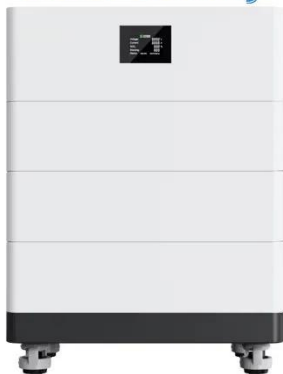
