These controls can range from allowing no export at all (zero-export) to limiting the amount of power based on time of day or current grid. 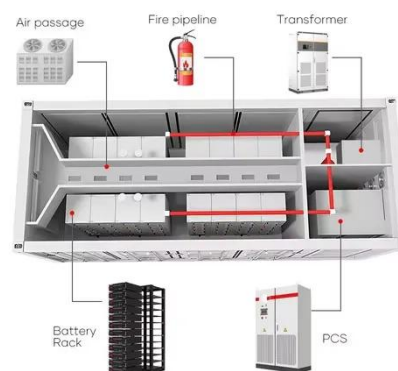
