

Solar power subsidies in arrears



Overview

In the United States, new Treasury Department figures show that subsidies for wind and solar dwarf all other energy-related provisions in the tax code, costing \$31. The United States, under the Biden-Harris climate bill, the Inflation Reduction Act, is expected to spend \$421 billion between. In its Short-Term Energy Outlook, the Energy Information Administration (EIA) is projecting 26 gigawatts of solar capacity to be added to the power grid this year and another 22 gigawatts of solar additions in 2026. That expected growth is down from the record 37 gigawatts of solar power capacity. 70% of the rooftop solar industry now uses lease arrangements, making the bill disastrous for companies like Sunrun.
