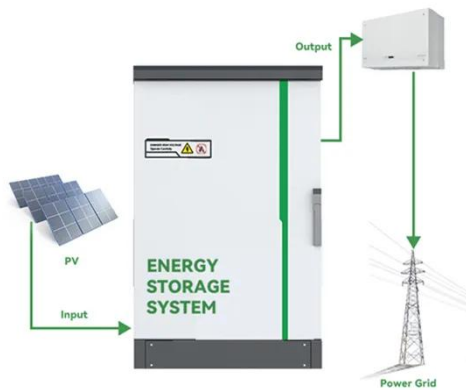

Since January 31, the delisting of Hairun has experienced 19 consecutive declines, falling by more than 83%, leaving only 850 million yuan in total market capitalization.

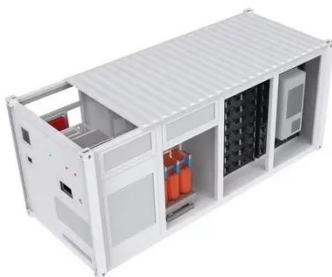
